Pediatric Dental EHB Model Contract Status

Purpose:

- To present changes made to model contract in response to comments
- To gather input on outstanding items

On June 19, 2013 Covered California released a draft Pediatric Dental Model Contract and requested comments from stakeholders and bidders. A few specific areas of interest in draft model contract;

- Attachment 7 Article 6 Section 6.01 Provider Cost and Quality
- Attachment 7 Article 7 Promoting Higher Value Care
- Attachment 14 Chart 3 Utilization Measures: Annual Preventive/Diagnostic Visit

Covered California has reviewed comments from stakeholders and bidders and made many modifications to the contract. A redline version of the Pediatric Dental Model Contract was released on July 19th.

Covered California has also identified those content areas which we believe to be significant and require more time and discussion to ensure that the best decision is made. This webinar will identify the areas of the contract that we will continue to analyze, with input from our plan partners and stakeholders, and communicate the decisions made in the future.



Pediatric Dental EHB Model Contract Changes

General approach: Be consistent with the QHP model contract when possible. Avoid re-litigating common issues.

- Deleted subsidy calculator requirement (Article 1, 1.05)
- Notification requirement limited to a network provider that the Enrollee is actively or has recently used based on claims data (Article 3, 3.23(a))
- Deleted requirement to review marketing materials for plans that do not include pediatric essential dental health benefit (Article 3, 3.26(c))
- SHOP Participation Fee same as Individual (Article 5, 5.03)



ID Card changes

Article 3 Section 3.26(d) Attachment 6 Item 6(c)(i)

 Covered California will allow electronic ID cards & no-card eligibility verification systems

Attachment 5 Provider Agreement- Standard Terms

Plan can implement provisions over time

- Deleted requirement to collect member's Sexual Orientation & Gender Identity data
- Privacy Concerns collaboration with Exchange
- Examples of Data Collection
 - Use of a Risk Assessment Tool
 - Analysis of utilization patterns to determine whether they vary by demographic factor
